# Agenda Point (2): -- Discussion on execution work of Painting our residential blocks & Boundary wall.

Our residential blocks were painted /colour washed in the financial year 2013-14. Now they have become due for painting again. The Executive Committee decided to take up the painting of residential blocks and boundary wall in FY 2021-2022.

Based on the recommendation of the Committee has decided in a meeting on 16.09.2021 that following areas will be covered under the scope of painting:

#### 1.1. Painting work Scope

- 1.1.1. Outside wall of the residential blocks and common areas weather Coat,
- 1.1.2. Garage will be painted with Distemper.
- 1.1.3. Painting of boundary wall will be from inside & front portion will be painted on both sides.
- 1.1.4. Badminton court will be painted.
- 1.1.5. Windows will be painted from outside and pudding/putty will be applied on glass panes of windows. (Note: Window grill will be painted with subjected to APPROVAL during AGM.)
- 1.1.6. Balcony grill for painting from outside.

#### 1.2. Civil work Scope

- 1.2.1. Common bath rooms in all blocks white cement grouting work. Outside wall of the residential blocks and common areas weather Coat,
- 1.2.2. Septic Tank Damp treatment. (Note- it is one of the recurring cost which ACFOA are accepted).
- 1.2.3. Repair work for all building structure, Boundary walls and Siva Mandir.

#### **Painting Agency:**

It was decided that painting would be carried out by a renowned company.

It was also decided to obtain from reputed companies within a given dead line.

The quotation were analysed by the Executive committee members & here is the detail process as below.

#### **Initial Participation**

- 3 paint supply company participated (Berger, Asian and Dulux).
- 6 Vendors for civil work (3 vendors recommended by Asian, 2 vendors by Dulux & and 1 vendor from Airport city).
- 6 Vendors from painting work (3 vendors recommended by Asian, 2 vendors by Dulux & and 1 vendor from Berger).

#### **Negotiation Stage**

- Paint Supply Asian Paints and Dulux called for negotiation as L1 and L2.
- Paint Application 2 Applicator for Asian Paint & 2 vendor for Dulux called for negotiation.
- Civil work L1 and L2 called for negotiation.



#### **Final Conclusion**

Recommendation from ACFOA will be provided during EGM and conclusion will be done during EGM.
